#### ORDER:

In the letters read above, the Commissioner, Women Development & Child Welfare (WD&CW) has reported that while implementation of ICDS has resulted in improvement of the nutritional status of women and children in the state, the desired goals have not been achieved. The percentage of low birth weight babies, underweight children (< 3 years) and pregnant women who are anaemic is still high. As a result, reduction of Infant Mortality Rate (IMR) and Maternal Mortality Rate (MMR) continues to be a challenge.

- i) **Low birth weight children** in Andhra Pradesh as per National Family Health Survey (NFHS -3) of 2005-06 was recorded as 19.4% which was highest among the other southern states.
- ii) *Underweight children* (<3 years) in Andhra Pradesh as per NFHS-3 was very high at 37%.
- iii) **Anaemia** prevalence in Andhra Pradesh increased among Ever Married Women (15-44 yrs) as per NFHS-2 and NFHS-3 from 49.8% in 1998 1999 to an alarming 62.9% in 2005-06.
- 2. In this regard the Commissioner, (WD & CW) has informed the following:
  - i) Malnutrition starts in early stages of life and children can be at risk of malnutrition even before birth. Scientific evidence has shown that beyond the age of 2-3 years, the effects of chronic malnutrition are irreversible.
  - ii) The high prevalence of chronic malnutrition can be tackled by addressing the nutritional requirements of Pregnant and Lactating women.
  - iii) The alarming situation of stunting in Andhra Pradesh (33.9% for children below 3 years as per NFHS-3) also indicates the need to address malnutrition in early stages by targeting the Pregnant and Lactating women and adolescent girls.
- 3. The Commissioner, (WD&CW) has therefore made the following recommendations:
  - i) There is a need to modify the nutrition programme of ICDS to address challenges in early stages of life itself by targeted approach
  - ii) Targeting Pregnant and Lactating women (i.e. mothers) and meeting their nutritional needs is one of the critical windows of opportunity to prevent malnutrition.
  - iii) This can be done by introducing spot feeding of "One Full Meal" for the Pregnant and Lactating women at the Anganwadi Centers (AWCs) along with administration of Iron & Folic Acid (IFA) tablet.
  - iv) Introduction of such a programme will have the following impact:

- Enhance the quality and acceptability of meals by the mothers
- Ensure food supplied is consumed by only the mothers rather than the whole family
- Ensure that Pregnant women consume 90+ IFA tablets.
- Improve the enrollment of mothers at Anganwadi Centers.
- Eliminate or decrease number of mothers with anaemia and under nutrition
- Reduce the incidence of low birth babies and malnutrition among children.
- Ensure that mothers receive health checkups and immunization.
- Reduce the incidence of infant mortality and maternal mortality.
- 4. The model for "One Full Meal" per day proposed for spot feeding of Pregnant & Lactating women is as follows:
  - i) The items included for the wholesome meal are:
    - Rice /Wheat / Millets
    - Dhal/ Sambar
    - Vegetables / Green Leafy Vegetables/Fruits
    - Eac
    - Glass of milk /curd
  - ii) The estimated quantity, nutritive value and cost of such a proposed "One Full Meal" is indicated at *Annexure I*. The cost of meal per day per mother will be Rs.15/. The meal will provide more than 40% of the day's requirement of calories, protein and calcium to the mothers. In addition, the spot feeding will ensure full consumption of IFA tablets.
- 5. The critical intervention of "One Full Meal" for Pregnant and Lactating women is proposed to be introduced in only those 102 Projects out of the 387 ICDS Projects which have been identified as high risk areas (wherein IMR, MMR and malnutrition levels are high). The list of these 102 Projects with the details of number of Anganwadi Centers and estimated number of Pregnant and Lactating women is at *Annexure –II*.
- 6. Under Supplementary Nutrition Programme (SNP) of ICDS there is already a budget of Rs. 5 per day per mother. Hence, the additional financial requirement for the "One Full Meal" will be Rs.103.20 crores per annum for the estimated 3.44 lakhs of Pregnant & Lactating Women in the 102 high risk ICDS Projects. The percentage of Anganwadi Centers in these 102 ICDS Projects which have more than 40% of SC/ST population is about 40% and hence Rs.41.28 crores can be met, if necessary, from SC/ST plan.
- 7. After careful examination of the proposal, Government hereby accords approval of the following:
  - i) To introduce "One Full Meal" for Pregnant and Lactating women under "Indiramma Amrutha Hastham" Programme as per the proposed model and cost as at *Annexure–I*. The costs will be revised in accordance with price escalation.
  - ii) To introduce "One Full Meal" in 102 ICDS Projects identified as at *Annexure-II* from 1st January 2013 onwards.
  - iii) To provide for additional State Budget for the "One Full Meal" programme for the Pregnant and Lactating women in 102 ICDS Projects over and above the normal nutrition budget.
- 8. Considering the importance of the scheme and the commitment of the State to protect the life of every mother & child in the State, the Commissioner, (WD & CW) is advised to evolve & design the implementation of the scheme in transparent manner and as an entitlement based scheme by creating awareness among the beneficiaries and with the necessary oversight mechanism, so as to ensure that the benefits reached the intended beneficiaries without any leakages or wastage.

- 9. The scheme will not be operated in habitations covered by the Nutrition cum Day Care Centers (NDCCs) of the "Indira Kranti Patham (IKP)" and there will be coordination with the Rural Development Department to avoid overlap with the NDCCs.
- 10. Any negligence, misuse, diversion and interruption of the "One Full Meal" to the target group will be viewed seriously and will entail stringent action against the concerned.
- 11. This order issues with the concurrence of Rural Development Dept. and Finance (Expr. WD&CW) Dept, vide their <u>U.O.No.9433/195/Expr.WD/2012,</u> <u>dt.10/10/2012.</u>
